# CONVENTION REPORT

REACT is your organization! Every member is receiving this Special Report so that you will have all the exciting news from the 1980 REACT International Convention held July 17-19th in Atlanta, Georgia.

Close to 300 people attended the Convention with 101 Teams and 30 States represented. Capital City Communications REACT C42 did a great job in planning and conducting the Convention. The Century Center Hotel provided a comfortable and decorative setting with outstanding facilities. We hope to publish photos in the REACTer that will capture the flavor of this event. A number of very informative seminars were conducted by leading REACT members from all over the U.S.A. Richard Town a member of the Greater London Council attended the Convention to learn about CB and REACT in planning for the new British version of CB to come. Members of REACT International's Board of Directors gamely participated in "The Dunking" and a warm spirit of harmony and goodfellowship was epitomized by the good time everyone had at the concluding banquet. A true sense of accomplishment resulted from the announcement and Election results at the opening session, the organization of The REACT Forum and the Open Session with all new and old Board members with Team Delegates asked to discuss and vote on specific issues.

NOW YOU'LL FIND ADVERTISING IN REACTER. In an action overwhelmingly supported by the Team Delegates in Atlanta, REACT's Board of Directors has instructed Headquarters Staff to solicit commercial advertising to be run in the REACTer. This change in policy is due to the decline in commercial publications serving CB operators and the fact that The REACTer has become a very attractive advertising "buy" for sellers of CB equipment, other communications gear and related electronics products. Through advertising revenue, it may be possible to improve The REACTer in many ways. The Autumn Issue will be the first to contain advertising. It will be mailed early in September and include detailed reports and photos from the Atlanta Convention and news about many Team activities. Send in news about your Team's activities. We expect to have more room to publish such material as we increase the size of The REACTer.

EMERGENCY FUNDRAISING PROGRAM EXTENDED. After hearing the full financial report of REACT International, the Team Delegates at the Atlanta Convention voted to have the Emergency Fundraising Drive extended until the end of 1980. At this time 110 Teams have responded with a total of \$5,374.20 In addition, several state councils have waived all or part of the funds available to them in reimbursement of 1979 and/or 1980 expenses. If your Team has not yet contributed, review your financial ability to make your contribution of \$37.93, or more with your officers. Perhaps your Team should schedule a fundraising effort and share the proceeds with REACT International. If all Teams do support this voluntary effort, we may be sure of ending 1980 with a small "rainy day fund". The Delegates in Atlanta were assurred that sufficient income has been raised to cover the debts remaining from 1979, so that they can be liquidated by the end of 1980, if our minimum income projections are achieved. 1980 dues are going exclusively for 1980 expenditures!

YOU HAVE A STAKE IN REACT'S FUTURE. Those who were in attendance recognized the increased income required to achieve minimum goals and still overcome inflation. (Our \$5 dues is worth just \$2.40 in 1975 dollars!) We are hopeful that a minimum financial burden will be placed on the membership with other sources of income becoming available. The Fundraising and Long Range Planning Task Groups along with the Forum Executive Committee and the Board of Directors are now studying the total financial outlook for 1981.

Preliminary 1981 budget proposals discussed in Atlanta break down to approximately \$200 per Team or \$10 per member for the total annual cost of REACT International operations. That does not mean that we are going to increase dues to \$10 per member to recover all of these funds. It does mean that an overall fundraising plan must be implemented to assure the level of income required to operate REACT International satisfactorily. Through the Forum structure, the membership has direct involvement in the decisions that will affect every REACT Team and member. Direct your input through the Forum structure on all these ssues.

An applicant for Life Membership must be an active REACT Team Member for three years or more; recommended by his/her Team and submit Life Member Dues equal to 20 times the Regular Member dues. Curently Life Membership dues are \$100 (considered fully deductible from U.S. Federal Income Tax in year paid). Life members have all the rights and privileges granted to individual Regular Members of REACT International, but are subject to the obligation of their local Team. Application forms are available upon request from REACT International.
