## FROM THE DESK OF THE PRESIDENT

**This is a special notice to all team officials of any *REACT* INTERNATIONAL Chartered TEAM.**

The IRS recently announced a one-time relief program for small tax-exempt organizations that FAILED to file either Form 990-N or 990-EZ for the last three (3) years. Filing 990s for smaller tax exempt organizations became a requirement with the Pension Protection Act of 2006, effective for tax years beginning on or after January 01, 2007. The relief applies to filers whose tax returns are due by October 15, 2010.

Those calendar year organizations that did not file were scheduled to lose their exempt status as of May 17, 2010. You must view the IRS list to make sure that your team's name does not appear. If it does, your team must file before the dead line of October 15, 2010, failure to comply; your team will lose the tax exempt status.

The Board, officers, and I cannot stress the importance of this matter to you, as a member of your team and *REACT* International. It is up to all of us to protect the tax-exempt status of our organization. If your team

needs help, please call your Regional Director, or contact the office by email. Also, be sure that the RI office has notice of compliance that your team has filed. This may be sent by email or snail mail.

**NOW, FOR THE NUTS AND BOLTS TO FIX IT,** There are two types of relief available under the special relief provision:

1. Organizations eligible to file 990-N should go to the IRS web-site ([epostcard.form990.org](http://epostcard.form990.org)), and electronically file the form by October 15, 2010. Generally, these are nonprofits with less than \$25,000.00 in annual receipts per year. (Most Teams should fall in here)
2. Organizations not eligible to file Form 990-N may use the Voluntary Compliance Program (VCP). Under the program, smaller tax-exempt organizations, those eligible to file Form 990-EZ for all three years, must file Form 990-EZ for its current tax period and the two prior tax periods by October 15, 2010, and pay a compliance fee based upon 2009 gross receipts.

*REACT* International currently has 157 Teams with 2,228 Members!

Out of 157 Teams, 37 do not have a team e-mail address.

Out of 2,228 Members, 1,423 do not have an e-mail address listed with headquarters.

Are you a team or member that has not listed your e-mail address with *REACT* International? If so you are missing out. Due to the increasing cost of postage, many notices and other information are now being sent out via electronic means. This is being done to help

keep costs down so as to not raise your membership dues.

## Is your Team “NIMS” Compliant?

This is a question we all have started hearing and can expect to hear more often. For some Teams, the question isn't a very important question. The question sounds simple, but the answer can be much more complicated. From the federal standpoint, the answer is basically “You are, if you say so,” or perhaps strictly speaking, “You are, if your Emergency Management Agency says so.”

Nation Incident Management System (NIMS) is a mandatory federal standard, but both “mandatory” and “standard” are often slippery terms, especially when applied to federal programs.

Homeland Security President Directive 5 (HSPD-5) requires all Federal departments and agencies to adopt NIMS. This same directive requires adoption of NIMS by State, tribal, and local governments as a condition for the federal disaster preparedness funding. None of this applies directly to *REACT* Teams and Councils. Under HSPD-5 private sector non-government organizations that are directly involved in response operations are strongly encouraged to have their response personnel receive NIMS training but there is no specific list of mandatory training established by FEMA or Department of Homeland Security (DHS) that applies to non-government organizations that are at the local level.

*REACT* Teams generally work under the auspices of their local Emergency Management Agency – some Teams may work directly with more than one local EMA depending on the area served by the Team. Councils are rarely involved in direct emergency response, but typically have a role on the coordination between their Teams and the State EMA and State VOAD.

State and local government emergency management agencies are required to report their progress meeting the federal NIMS Implementation Objectives using a system called NIMSCAST, the National Incident Management System Capability Assessment Support Tool, where each EMA outlines their plans to implement NIMS within their agency.

As part of the agencies' plans to implement NIMS, the agencies may adopt standards for their personnel and for any local volunteer organizations that are recognized in the local emergency operations plan. Meeting such standards is voluntary for *REACT* Teams, but if you want to be recognized and accepted by your local EMA, it is important that your Team members work towards meeting whatever guidelines your EMA sets and the Team maintain records that can show what training your members have completed.

You may also find that other organizations you work with are adopting NIMS training standards for their volunteers and they may expect you to meet those same standards if you are going to work together.

FEMA has published a Five Year Training Plan for NIMS which outlines their vision of NIMS training. Most of this plan will not apply to individual *REACT* members, but Team and Council leaders should review the plan to at least so they will understand what EMA officials mean about

when they talk about NIMS training, Visit the FEMA NIMS Resource Center website at [www.fema.gov/emergency/nims/NIMSTrainingCourses.shtm](http://www.fema.gov/emergency/nims/NIMSTrainingCourses.shtm) for detailed information.

For *REACTers*, NIMS training should start with the two on the Incident Command System (ICS) introductory courses and the two overview courses. All four of these basic courses are available online from the FEMA website at no cost.

- IS-100a Introduction to the Incident Command System
- IS-200a ICS for Single Resources and Initial Action Incidents
- IS-700a National Incident Management System (NIMS), An Introduction
- IS-800b National Response Framework, An Introduction

There are a number of other valuable courses available online, depending on the needs and interests of your Team. For example, Teams in farming communities may be interested in IS-111, Livestock in Disasters, while Teams along the Gulf and Atlantic may be more interested in IS-324a, Community Hurricane Preparedness.

Team and Council officers should look at additional courses such as IS-244, Developing and Managing Volunteers; IS-288, The Role of Voluntary Agencies in Emergency Management, IS-317, Introduction to Community Emergency Response Teams, and IS-802, Emergency Support Function #2, Communications.

## Central Oklahoma REACT Team 6023 Responds to Tornado Disaster

It was around 4:30 pm. On May 10, 2010 and the National Weather Service in Norman had just issued a severe thunderstorm warning for Oklahoma County. Tornadic storms were developing rapidly and moving rapidly across central Oklahoma. The storm spotters from Central Oklahoma REACT team 6023 were activated. REACT members Denise Hines and Rob Anderson were assigned to the American Red Cross Headquarters and REACT member Bryan Packebush was assigned to the Emergency Operations Center in OKC. President Chris Toner was in charge of the incident command center until the other REACT members made it to their posts. REACT Vice President David Spaulding and Board Member/Recruiter Keith Sossamon, were already in the field storm spotting.

Both Sossamon and Spaulding were eastbound on the interstate, Spaulding on I-40 and Sossamon on I-240, following the storm as it proceeded into eastern Oklahoma County. Traffic was very heavy with motorists who did not know what to do. Sossamon had his hazard lights on, alerting other drivers that he was driving cautiously towards the back edge of the storm. Watching the road and trying to watch for developing tornadoes was no easy chore, so safety was the first concern. Staying west of the storm was top priority, in order to keep from driving right into it.

As Sossamon was approaching the intersection of I-240 and I-40, where it connects just west of Choctaw Rd, several emergency vehicles started passing him up. Then, traffic came to a standstill. Both Spaulding and Sossamon were in contact with each other via two-way radio and were trying to determine why traffic had stopped. Spaulding was stuck in the east bound lanes of I-40 and Sossamon was stuck in the east bound lanes of I-240...both of them just west of Choctaw Rd. As traffic moved, Sossamon could see heavy damage at the Love's Country Store and knew right away that a tornado had just hit.



Both Spaulding and Sossamon contacted President Toner and asked for authorization to turn on their hazard lights to get around traffic and assist authorities with medical, search and rescue. Once authorization was given, both Sossamon and Spaulding turned on their hazard lights and followed other emergency vehicles to the scene. Once on the scene, Spaulding grabbed his medical bag and both he and Sossamon started assisting law enforcement and medical personnel with injuries and debris removal. Since cell phones were not working at the time, Sossamon and Spaulding had to rely on their two-way radios to communicate to the command post at the American Red Cross Headquarters.



After spending a couple of hours on the scene and assisting Oklahoma County Sheriff's Deputies, OKC Police, Oklahoma Highway Patrol, OKC Fire and EMSA, Sossamon and Spaulding were released from the scene by OHP. By that time, traffic was moving once again and debris was removed from the interstate. Once released from the scene, both Sossamon and Spaulding headed towards the American Red Cross Headquarters for a de-briefing. There were quite a few emergency workers on the scene, but members of Central Oklahoma REACT Team 6023, were there very quickly and assisted in a professional manner.

## Shocked by the Lack of Ability to Communicate!

Were you as baffled as I by those "Fast Facts" the IT Committee sent us? If not, look at them again - and wince.

25% of *REACT* Teams have no email address on file with RI. Nearly 70% of *REACT* members are in the same boat.

For Teams and individuals that claim to be 'Emergency Communicators' this is nothing short of dismal. In 2010, it is worse than that. We are well into the computer age now, yet these Teams and members are unreachable by RI via e-mail in case of an emergency.

These same folk ask RI to build 'working relationships' with FEMA, NVOAD, etc., and to seek 'national PR' for *REACT*. Why? RI can't get a key message from these bodies to its full membership in an emergency. Talk about humiliating.

When RI does receive national publicity, it can't provide potential new team member inquiries with an email address for 25% of its Teams. Think of the impression that makes on the young, computer-savvy people that *REACT seeks and needs to swell its ranks*.

Please, make it your personal mission to improve this situation locally. Check with all your *REACT* friends to ensure that RI has a contact email address for each. Check with neighboring Teams to ensure that each has an email address on file with RI. Where you find no contact exists, please invest some time to help that *REACT*er or Team to get an email address and provide it to RI. (The RI website will show you which Teams in your area have no email address.)

Hotmail and Gmail are free. Public libraries offer free computer use. RI should therefore have an email address for virtually every *REACT* Team, and likewise for almost all *REACT* members.

Remember your own Team too. Does RI have a Team email address for it? Are email addresses on file with RI for all your Team members? Ask your Team Secretary about it. Check the RI website for your Team listing and your personal email address as well. Are they current and accurate? Update them as necessary.

Let's make this a 50th Anniversary project. Let's get these 'absentee' figures down to about 1% before our 50th. It needs you to succeed. Go to work on it today. Help some *REACT*er's in your area to be in touch with RI.

## Jack Griffey #07 and a Celebration of his long-standing Presidency

Jack Griffey, a former United States Marine, along with two other friends founded what became Douglas County *REACT* in 1969. Three years later Douglas County *REACT* was incorporated and granted tax exempt status. Eventually the name was changed to Heartland *REACT*.

Through out the past 40 years, Jack has fearlessly lead Douglas County *REACT* though many years of change and in supporting the Omaha Metro area. As an Omaha firefighter and paramedic, Jack recognized the need to organize communications and setup a team. Jack got the team into storm spotter training after establishing a relationship with Civil Defense and the National Weather Service.

There were a number of disasters requiring emergency communications, most notable a massive blizzard that hit the Midwest in January of 1975, and the historic F4 Tornado that ripped through Omaha four months later. Because local radar was washed out and virtually useless at the time and the Ak-Sar-Ben Amateur Radio Club did not have ARES storm spotters at the time, Douglas County *REACT* was the first to report the tornado as it touched down near 108<sup>th</sup> and Giles and reported the Tornado's location to the Sarpy County EOC as it moved towards 72<sup>nd</sup> Street. About 15 minutes of warning was given to Ralston and Omaha. After the tornado dissipated, *REACT* was used to secure an apartment complex while search and rescue was conducted, and was later reassigned by the State Patrol for various tasks.

For several weeks after, Jack directed the team in disaster recovery his home as a headquarters.

Damage assessments were taken for the Red Cross. Later, Jack donated his van when the original communications trailer was retired. This and other acts of generosity and organization show the heart that Jack has and his dedication to Heartland *REACT* and the Omaha community.

Douglas County *REACT*, like many other *REACT* chapters utilized Citizens Band Radio as its first form of communications during the CB craze. During the

storms of '75, Douglas County *REACT* was using Class-D CB radios, establishing a Net under the call sign KDR-0868. Because of the limited capability of Class-D CB radios, the use of Class A CB was explored. After the Tornado of '75, enough money was donated to DC *REACT* to fund the purchase a repeater. A used tube-based repeater was purchased at auction from Omaha Public Power District.

Because the members were not able to modify the repeater to the desired frequency, they were forced to use the frequency it was already set for, 462.700 MHz and the appropriate license was acquired. Two years later, a solid state repeater was purchased with money donated from the Knights of Ak-Sar-Ben. The frequency stayed and has been the same ever since. Eventually Class A Citizens Band evolved into what is now known as the General Mobile Radio Service (GMRS).

In order to provide the best communications modes available, 34 years after the initial repeater's setup, a vote was taken to move Heartland *REACT* from GMRS to the Amateur Radio band, though members are encouraged to continue to maintain their GMRS licenses to present a greater value to the team.

Jack also lead Douglas County *REACT* though the changing world of emergency communications. In a time where *REACT* may not have always had a clear path, Jack helped lead *REACT* though many years of change. Local law enforcement is not as willing to work with *REACT* as it once had been. However, Jack still maintains connections with members of law enforcement, the fire department, and many other organizations in the community such as CERT and OMMRS.

The members of Heartland *REACT* want to thank Jack for his many years of dedication and leadership to *REACT* and for his contributions to the Omaha community. As he hands over the reins of the Presidency, we welcome Jack to the Board of Directors and plan on utilizing his leadership skills and experiences for many years to come.

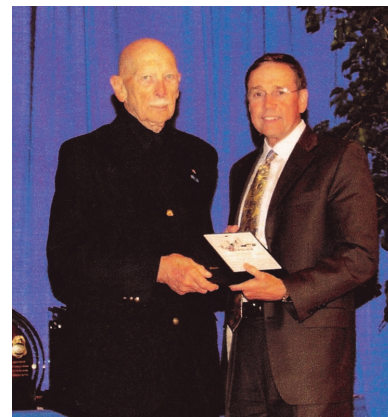
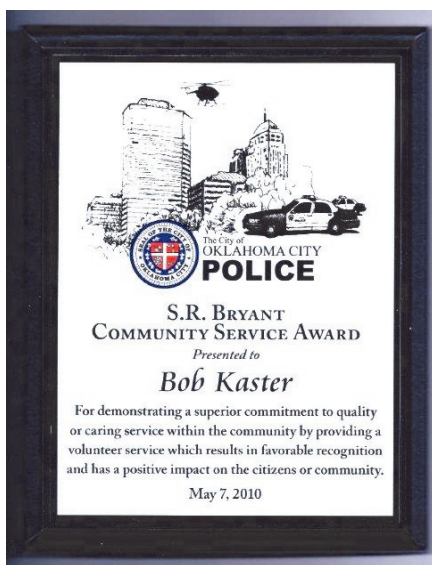




## Oklahoma City Police Department Awards the S.R. Bryant Community Service Award

### *Traffic Control Assistance to Cleveland Fire Department*

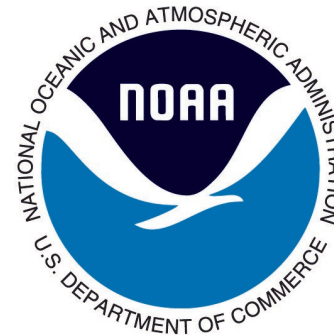
On the same night of the severe weather as Chief Flora was on his way home he assisted the Cleveland Fire Department with traffic control to help slow traffic on the road as the accident was just on the other side of the curve. The road was then closed briefly while the rollback loaded the car. Chief Flora was then on his way home again.

### *Severe Weather Cause Traffic Accidents in Shelby, NC*

On August 5, 2010 at about 18:25 hrs., Chief Jay Flora, of Cleveland County *REACT* in Shelby, was out in the community due to severe storms in the City and County of Shelby. Ten minutes later Chief Flora alerted the NWS to a funnel cloud on Old Boiling Springs Rd just off of Old Sheriff Allen Rd, which came over the County Fire Channel he was monitoring. At about 18:50 hrs. Chief Flora had to pull off Hwy 226/ Polkville Rd at Hwy 74 due to the fact that the rain was coming down so hard he could not see. Chief again

called into NWS to report the driving rain, wind, lightning and hail in his area, at that time the NWS alerted Chief Flora that there was a storm warning for the City of Shelby and Cleveland County. He was able to continue to driving about 45 minutes later, as the rain had slackened, he continued toward the City of Shelby when he saw a car in a ditch, water was filling the car and flooding the road.

Chief called the Shelby Communication Center to advise that the driver of the vehicle was ok, Chief then used his four way flasher to alert traffic to the danger while they waited for law enforcement to arrive, once they arrived they asked him to continue with his efforts within the city limits as they were extremely busy from the storm and they sure appreciated the help Chief Flora was providing.

Assistant Chief Armingier was on hand to provide real world feedback to all participants and to oversee the training evolution. Participants came in from various CERT Team in the Tampa Bay Region to participate.

## REACT Helps Easter Seals

REACT Lake Simcoe (ON) has provided safety communications for a Crippled Kids event for about 30 years. The Team is 31 years old.

Almost as soon as the Team formed, officials with the "Persechini Run/Walk for Easter Seals" requested REACT radio assistance for their new event that supports disabled kids. Perhaps 200 people participated in those early days.

Today, over 2,000 runners and walkers trek the 10K course to raise funds for disabled children. Some years the event is an accredited 10K race and runners come from afar to compete. Over the years, the route has changed several times to handle the growing numbers amid much heavier traffic.

In the same period, REACT Lake Simcoe gave birth to REACT Don Valley. The two Teams now work the event together, with the younger REACT Don Valley now taking the lead.

Few incidents have arisen over the decades to test the REACTers. The most serious was a surprise near-tornado several years ago. REACTers used their vehicles to shelter walkers from hail and rain. One REACT vehicle and its rescued passengers were trapped by fallen trees for a time. Buses are now on stand-by should Mother Nature throw another tantrum.

Occasionally, a child becomes separated from parents or someone experiences a medical problem. REACT radio links help to resolve those situations speedily and have brought high praise over the years.

The event takes place on the final Sunday of May. Thus, it usually is the Teams' wind-up activity for REACT Month. What a great way it has become to wrap up our REACT Month celebrations.
