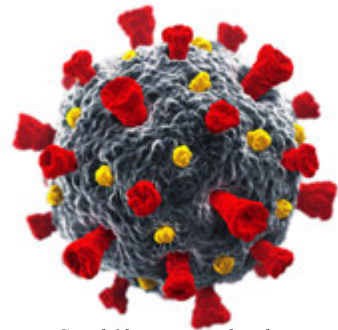

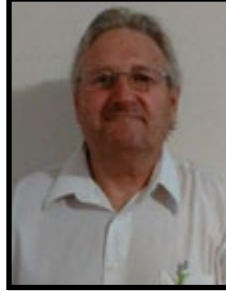

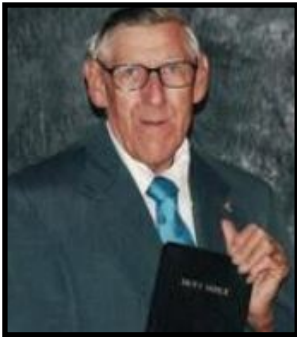
Barbara Chalfant Zych **1951 – 2021**

***REACT* Responds To La Soufrière Volcano Eruption in St. Vincent**

St. Vincent and the Grenadines is a southern Caribbean nation comprised of a main island, St. Vincent, and a chain of smaller islands. See map for location.

St. Vincent is the home to the La Soufrière Volcano, which recommenced volcanic activity on 29th December 2020. A rapid increase in volcanic activity and effusive eruptions occurred on 9th April 2020 and continues apace. Due to close monitoring by UWI Seismic, NEMO, and other agencies, evacuations in the “red zone” commenced before the eruptions. The entire island ended up being covered in ash to some degree.



The Argyle International Airport had to be closed for a while. All of this is happening in the midst of the COVID-19 pandemic, which has its own challenges. A major relief effort is underway to assist the affected nation.

Radio operator J88DM, Reni King in St. Vincent, has been providing regular updates since the eruptions started. Some of his updates have been featured on local radio and TV broadcasts. He has also been the primary contact in the *REACT* efforts to assist the radio community in St. Vincent. So far, through the generosity of *REACT*ers and other stakeholders, several critical items have been sent. 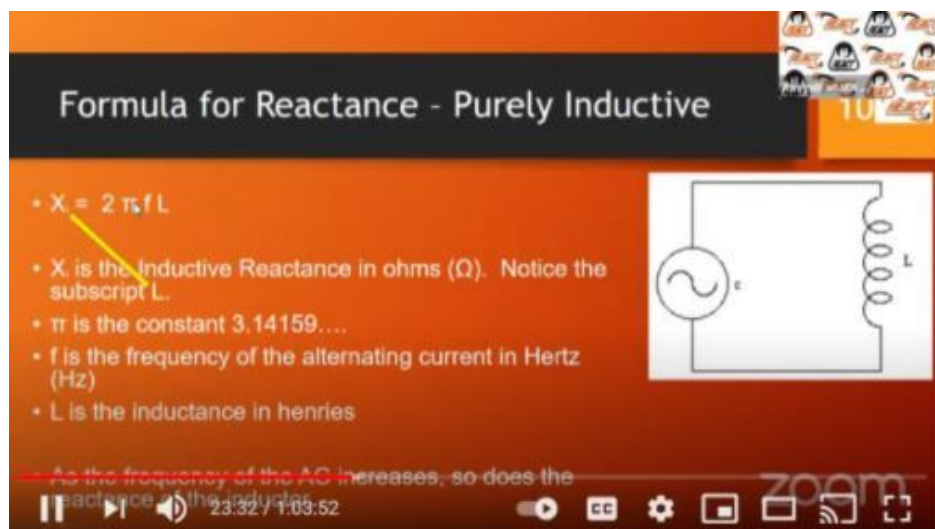

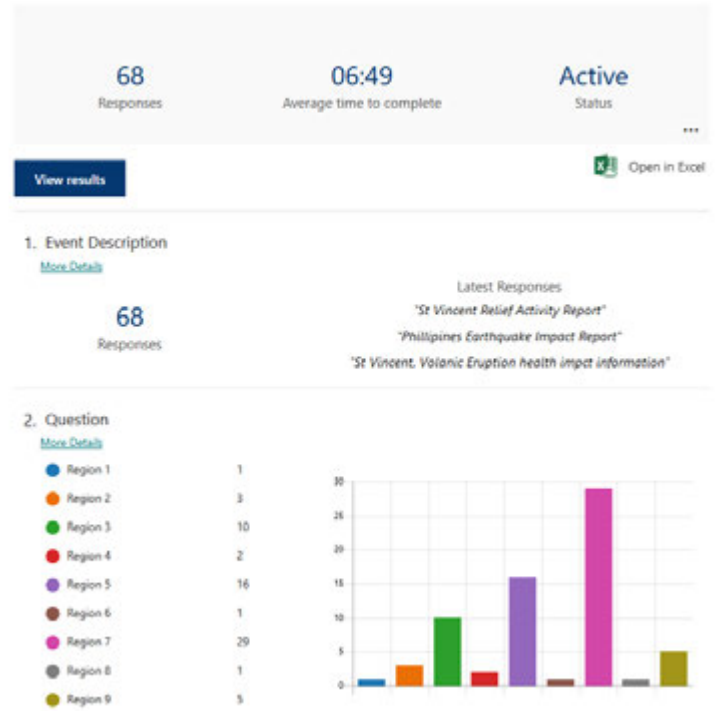
In the spirit of being open, the *REACT* Traffic System and the Warning Team is reporting key data points from or reporting systems of hazardous events that directly impact *REACT* International Teams, ranging from financial support and impact to membership growth and operational metrics. These data analytics help us make appropriate investments, and author and implement operational planning objectives, helping us to ensure we deliver welcome and valuable resources to communities affected by disasters.

The hope is this data provide relevance and insight of the true nature of the *REACT* International teams mission, the efforts of our volunteers, the contribution of our donors, and our value to supporting the efforts of our fellow NGO organizations, academics, government and anyone else committed to helping people and communities in need.

The following metrics comprise the result of a pilot program begun in Mid-March 2021 by the Warning Team and a large portion of the data comes from the work of the *REACT* Traffic System Traffic Handlers in Region 7 Traffic 711 Kansas and Traffic 741 Texas, the information shown is meant to demonstrate *REACT* Team organizational high-level indicators of investment, outcomes and impact.

As the Traffic System Manager, I am pleased with the initial results of the pilot program and the invaluable cooperation and dedication of the traffic handlers who participated in it and without their help it would have failed. The pilot will transition to an initiative for the remainder of April. The next report you see will include metrics from all *REACT* International Regions. We are seeking help with this effort by having at least one Traffic Handler from each state, a traffic handler can come from any team, but must be approved by the Regional Director and team leadership. It is not the desire of the Traffic System that the participation of the team member diminishes the mission capability of their team of origin but enhances by being a liaison between the Team and Traffic System.

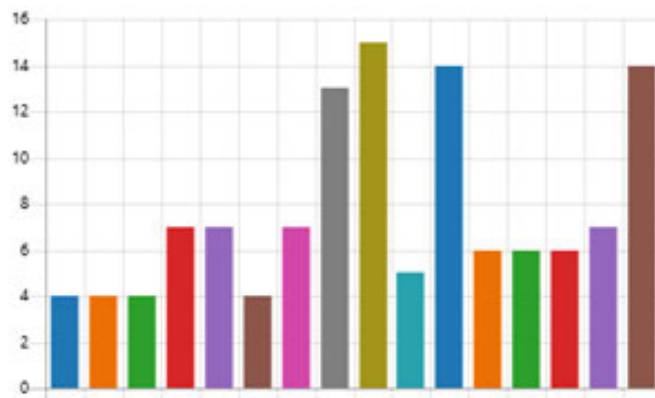

FCC ENFORCEMENT ADVISORY

WARNING: AMATEUR AND PERSONAL RADIO SERVICES LICENSEES AND OPERATORS MAY NOT USE RADIO EQUIPMENT TO COMMIT OR FACILITATE CRIMINAL ACTS

The Enforcement Bureau (Bureau) of the Federal Communications Commission issues this Enforcement Advisory to remind licensees in the Amateur Radio Service, as well as licensees and operators in the Personal Radio Services, that the Commission prohibits the use of radios in those services to commit or facilitate criminal acts.

The Bureau has become aware of discussions on social media platforms suggesting that certain radio services regulated by the Commission may be an alternative to social media platforms for groups to communicate and coordinate future activities. The Bureau recognizes that these services can be used for a wide range of permitted purposes, including speech that is protected under the First Amendment of the U.S. Constitution. **Amateur and Personal Radio Services, however, may not be used to commit or facilitate crimes.**

Specifically, the Bureau reminds amateur licensees that they are prohibited from transmitting “communications intended to facilitate a criminal act” or “messages encoded for the purpose of obscuring their meaning.”¹ Likewise, individuals operating radios in the Personal Radio Services, a category that includes Citizens Band radios, Family Radio Service walkie-talkies, and General Mobile Radio Service, are prohibited from using those radios “in connection with any activity which is against Federal, State or local law.”² Individuals using radios in the Amateur or Personal Radio Services in this manner may be subject to severe penalties, including significant fines, seizure of the offending equipment, and, in some cases, criminal prosecution.³

**STATEMENT OF
ACTING CHAIRWOMAN JESSICA ROSENWORCEL**

**Re: Amendments to Part 4 of the Commission's Rules Concerning Disruptions to
Communications, PS Docket No. 15-80, Second Report and Order (March 17, 2021)**

They say everything is bigger in Texas, and so it goes for winter storms, too. Last month, Winter Storm Uri hammered the United States, leading to severe weather in 25 states affecting more than 150 million Americans. So many parts of the country—from Maine to Oregon—were blanketed in snow, ice, and frigid temperatures. But Texas was hit the hardest.

For Texans, it was a crisis within a crisis within a crisis. The state's independent power grid failed, leaving millions without power. Water treatment plants failed too, leading to boil warnings across the state.

The loss of any of these fundamental utilities is a crisis unto itself. But in Texas one storm brushed up against another: a pandemic that has driven life online. After months of being stuck at home, many Americans know full well that—like power and water—internet access is essential. These days we need it to work, go to school, see a doctor, or stay connected to civic and economic life. But in Texas and Oklahoma, Winter Storm Uri also caused widespread communications outages. At one point, nearly 400,000 wireless users were without service. At the same time, more than 720,000 VoIP users were affected. These failures are especially serious because they can hamper emergency response and disaster relief efforts.

Today, the snow has melted, the freezing temperatures have warmed, and power has returned. But we will be dealing with the aftermath of this storm for months to come. It is a reminder that so much of our critical infrastructure is fragile. On too many occasions when disaster has struck, this also has been true for communications. We have seen it in season after season of hurricanes in the south and wildfires in the west. The names stay with us—Maria, Irma, Harvey, Michael, Camp, Woolsey, Kincade—long after the water has receded, the flames have extinguished, and the communities affected have begun the hard slog of repairing and replacing essential infrastructure.

Mother Nature's wrath is sure to visit us again. So are 911 failures and power outages and other threats to network infrastructure. That's why I believe the Federal Communications Commission needs to fundamentally refresh its playbook for disaster preparedness and resiliency. And we start that effort today, by updating our network outage reporting rules.

Right now, the Commission collects outage information through its Network Outage Reporting System—or NORS—and its voluntary Disaster Information Reporting System—or DIRS. But for too long we have held this information for ourselves, sharing it only with the Department of Homeland Security. That means we have shut out other government partners in disaster. But we know that when the unthinkable occurs getting out accurate information about communications and outages can save lives and property. It can help speed restoration of service. So in this decision we right this wrong by creating a framework to provide federal, state, local and Tribal partners with access to the NORS and DIRS information they need during emergencies, natural disasters—and now pandemics.

This decision is good news for public safety. It will promote better information sharing and awareness during emergencies. This effort is also overdue. It was more than ten years ago that the California Public Utilities Commission petitioned this agency to help provide state authorities with timely access to outage information like what we have in DIRS. It was five years ago that this agency issued a rulemaking that proposed to grant state officials access to NORS data regarding outages in their states. I am happy that we are finally taking this important action in my second meeting as Acting Chairwoman so that we can continue to improve the way we work with state public safety officials to help restore communications after a disaster.

**STATEMENT OF
COMMISSIONER BRENDAN CARR**

**Re: Amendments to Part 4 of the Commission’s Rules Concerning Disruptions to
Communications, PS Docket No. 15-80, Second Report and Order (March 17, 2021)**

When a hurricane tears through a community, leaving downed power lines and bent towers in its wake, federal and state agencies immediately rush in to help. They are part of a large group of private sector and government officials alike that go to work whenever a natural or manmade disaster strikes.

I had the chance to see firsthand the work they do to restore vital services in the aftermath of a crisis when I spent time with telecom crews and first responders in Mexico Beach, Florida—ground zero for the Category 5 Hurricane Michael.

One thing that stood out to me is the need for all of these federal, state, local, and private sector entities to coordinate. Indeed, efforts to restore some services, like power or water, can often result in inadvertent cuts to telecom lines.

This is where better coordination and communication can make sure that restoration efforts do not get stuck in a one step forward, two steps backwards dilemma. Today’s decision helps further this interest by ensuring that qualified federal, state, and Tribal partners with a “need to know” will now have greater access to outage information.

At the same time, we take steps to safeguard this sensitive and confidential data. Indeed, I would like to thank my colleagues for agreeing to additional edits that strengthen the item in this regard and ensure providers have better vision into how this information is being used.

Ultimately, our decision here will empower first responders—from public safety officials to the telecom crews that hit the ground the moment it is safe—so that services are restored as quickly as possible.

Thank you to the Public Safety and Homeland Security Bureau for your work on this Order. It has my support.

**STATEMENT OF
COMMISSIONER GEOFFREY STARKS**

**Re: Amendments to Part 4 of the Commission’s Rules Concerning Disruptions to
Communications, PS Docket No. 15-80, Second Report and Order (March 17, 2021)**

During an emergency, fast and effective coordination—across levels of government, among first responders, and across industries—can save both lives and property. I am pleased to approve this Order, which promotes coordination and information sharing among officials in emergency management and first responder support roles in the states, the District of Columbia, Tribal nations, territories, and the federal government by giving them access the Network Outage Reporting System (NORS) and Disaster Information Reporting System (DIRS).

Last year, before the pandemic curtailed our travels, I visited Puerto Rico to learn more about improving the resiliency of communications networks since Hurricanes Irma and Maria. Many individuals and representatives from local government, the labor movement, the healthcare and education sectors, disaster recovery workers, and the communications sector shared their on-the-ground experiences with me. Those conversations highlighted an important theme that I have seen play out a number of times since then: disasters rarely impact just one or a few parts of our day-to-day lives. If a weather event has caused power outages, it is probably also affecting communications networks, water services, and other systems we rely on every day. Effective disaster response and recovery requires all levels of government to see the big picture.

Today’s decision will help facilitate the predictable, fast, and efficient information sharing that seeing the big picture requires. The severe and unusual weather that many parts of the United States have experienced in recent weeks underscores the need to move quickly and decisively on issues around network resiliency. We know that climate change will make natural disasters more frequent and more severe, making steps like today’s Order all the more urgent. Many thanks to the Public Safety and Homeland Security Bureau for their hard work preparing this Order.
