

#### SEARCH FOR MISSING AIRCRAFT COORDINATION AND PREPAREDNESS LEAD THE WAY

On Thursday, May 10, 1990, a Cessna 210 aircraft with six men aboard left Manteo, North Carolina enroute to Leesburg, Virginia. It never arrived. The men on the plane were returning from a fishing trip when their place disappeared. presumably somewhere between Richmond. Virginia and Gaithersburg, Maryland. The pilot did not file flight plans before departing so did not track the radar plane's course.

The Civil Air Patrol and the Appalachian Search and Conference Rescue began their formal joint search for the plane at sunrise on Friday, May 11. Prince William REACT Team C-109 contacted the searh groups. registering Team's availability to help with the search. At this time a Team member was dispatched to Manassas Municipal Airport command post to serve as Liaison Officer and the rest of the Team was alerted to be on standby via a telephone call-up precedure which had just been implemented two days prior.

Over the next nine days, 83% of Team C109's active membership participated in support of the search, which according to a CAP spokesperson was the largest of it's kind in this area. The Team assisted with logistics and search team transport. Food, supplies, and equipment were also transported.

On Saturday, May 12, Team members were canvassed for transport, onside, and Radio Net availability. Nets were established on both the east and west end of

the county and some mobile units were put into service for logistics and search team transport.

On Sunday, May 13, an onsite station was put into operation to assist the search efforts being coordinated by CAP and ASRC within Prince William Forest Park on the east end of the county. Food service was supplied with the assistance of the Dumfires-Triangle volunteer Fire Dept. Auxiliary and Red Cross Disaster Services. Transport of people and supplies panded on both ends of the county. Quick retrieval of search teams was required in the afternoon when the National Weather Service issued a tornado watch for the entire area and a tornado warning when a funnel cloud was spotted to the west.

From Monday, May 14 to Thursday May 17, the search continued. The Team continued on-site services at Manassas Airport with the west-end Radio Net operating continuously from 0530 to 2400 daily.

The plane and remains of the occupants were located at approximately 1300 hours on May 17. Available mobile units were dispatched Manassas airport to close the airport and provide traffic and crowd control at the request of Virginia State Police. The VSP later praised the Team for speed and reaction and efficiency with which this action was accomplished.

On Friday and Saturday, May 18 and 19, cleanup activities were performed at the airport by the Liaison and

#### TRAGIC ERRORS

It began at 2335 on Thursday, June 15. So loud and clear were the transmissions that the trucker calling could have been on nearby highway 400 in Ontario. His broken messages and their content revealed otherwise.

He was calling Hagerstown REACT and reporting a vehicle travelling the wrong direction on I-55 at marker 75. He gave no state. stown, MD came to mind but it did not match with 1-55. Several times broken the message came across the Out airwayes, but no state. National came the graphic Atlas and the road atlas. NG showed a Hagerstown in Indiana, but 1-55 misses Indiana too.

Suddenly, the message changed. Now he was reporting that the vehicle had collided head-on with an 18-wheeler at marker 73. This time one of his calls mentioned Missouri State Police. I began a landline to MSP. I

had been unable to locate a Hagerstown in MO but maybe it was too tiny to be in the atlas.

After I completed the call, I was relieved to hear him thanking another REACT monitor somewhere. I hope that REACTer had fuller information than did I, but we had lost a lot of time regardless.

I continued to check the atfound lases and Hagarstown (note the spelling) in IL, reasonably close to 1-55 and marker 73. I believe now that the information I had, likely sent MSP on a wild chase, but I don't goose Hopefully, the other know. REACTer notified ISP so at least both locations were I don't know how checked. serious the collision was either, but I do know that tangles with 18-wheelers are usually very serious.

All the message lacked was

a state, but it delayed the arrival of help by at least ten minutes. Ten vital minutes.

Embarrassed at having perhaps sent MSP to an accident that seemed later not to exist, but relieved that someone else had hopefully been more help to the trucker and the accident victims than I had, I returned to bed.

Within seconds I heard a monitor saying, "Yes, you are on Pike Creek, the water is rising, and people are trapped. Where is Pike Creek?"

I went to the radio, hoping that perhaps I could hear something the other monitor could not. Nothing. I did hear the monitor ask several more times for the location of Pike Creek. He mentioned notifying police, likely in his own state, but seemed helpless as to where to direct them.

Friday morning as I prepared for work I learned from the news that Pike Creek was in eastern Ohio. At least twelve people had died in a flash flood along the creek the night before. Had the monitor I heard had a location perhaps some of those lives could have been spared.

How seriously does your Team take its educational role in the community? many groups has a speaker from your Team addressed on correct CB use in emergencies? How many hundreds- yes hundreds - if not thousands. of copies "Getting Help by CB Radio" has your Team distributed? Is it available at all the truck welcome centers. service stations, police detachments, ect., in your vicinity?

Monitoring is only part of

our REACT role. Educating CBers in correct emergency radio use is another major part. Unless we do it, no one else will. Unless we do it, we will continue to get incomplete calls upon which we are helpless to act.

Review your Team's activity in this vitally important area. How well is it fulfilling this part of its role? Most of us can likely do better. When we do, remember it will bene-

fit not only our Team but all other Teams too.

Most importantly, it will benefit those millions travelling our roads and waterways who mistakenly think that just having a CB along is enough. We know it isn't.

We know you must use it skillfully to get help in an emergency. We must do more to ensure that they know. We must do more to help reduce those tragic errors.

Where are we going???

A question raised by all lev-Even more els of REACT. important...

Where are we??? What are our capabilities??? When are we on the air??? How are we doing???

REACT International, Inc. has sent out a survey to answer some of these questions. From the answers that have been returned to Teams REACT. monitor Channel 9 although not necessarily 24 hours. Some Teams monitor during the day, others during the night -- as an organization, we need to share the information on how these times are covered and methods on approaching people to work these hours.

Do we as an organization need to provide other languages for FCC Part 95D, in Spanish, Chinese, Sweden, and Vietnamese that cover Citizen Band Channels? Dο we on a team level need to be-lingual?

Due to noise on CB Channel 9- skip, foreign language, bleed over from other channels, many groups are monitoring General Mobile Radio Service since it is a quieter service. Mobile units monitor both CB Channel 9 and report problems over GMRS. GMRS does have a drawback since the general monitoring public does not have this communication service. **GMRS** use Teams communications, backup communicaadministrative

#### **INCORPORATE YOUR REACT TEAM**

Do the members of your Team a favor. Encourage them to incorporate. Save yourselves grief.

Incorporation is an absolute necessity in today's lawsuit - crazy world. It protects Team members from being sued individually if a lawsuit results from a Team activity. That is important protection.

When a Team is incorporated, only the assets of the Team (i.e. Team funds, Team equipment, ect.) are at risk in a lawsuit. Most Teams own too little to be a

worthwhile target.

If your Team is not incorporated, however, someone can sue each member. That can put your house, your car, your bank account, ect. at risk. Even if you win, the legal costs can be crippling.

Begin the incorporation procedure right away. It is easy and inexpensive if someone on your Team does it. A lawyer who is a friend of your Team may do it as a public service or at minimal cost.

Ask other Teams within your REACT Council that have already incorporated for information and help. Most will be happy to assist.

Be careful. Put as little as possible into your incorporation documents. Include only the required items.

The reason is that if you wish to change anything later you will have to pay all over again. Changing is just as costly as starting up.

A worthwhile bonus awaits Teams that incorporate. You

may find it much easier to interest businesses in donating to your Team. Incorporation causes them to consider your Team more favorably. They will know your Team is likely to be around for some time. They will also know your Team operates on sound. business-like principles.

Contact the state or provincial department that regulates business. Your REACT Council or nearby incorporated Teams can help you there.

The government agency will send you the papers and most likely an instruction booklet to help you complete them.

It is a wise idea to incorporate with REACT as the first word in your Team name (e.g. REACT Cincinnati, REACT Tucson, ect.) Again, remember that a change later will mean costly fees all over.

Start now. Take your time. Talk to other teams. Someone on your Team who has the time to work on it can do the job. The government fees are about \$100. Ask other Teams about their costs.

Once your Team incorporates everyone can sleep easier. Until then, they are operating under a false sense of security. Ignorance is not bliss.

Incorporate your Team just as soon as you can. Give your members the legal protection they deserve as dedicated volunteers.

## GMRS...Rx

Looks like the Field Directors want me to stay until I get it right.... Ned Smith says "Practice makes perfect... and I want you to keep practicing", so I guess you folks in REACT land are stuck with me for another year.

I learned two things at convention: first, there are a lot concerning questions of CARS radio. Thank heaven I had Leigh Bartlow (AL) and Chuck Thompson (TX) at the meetings to answer some technical questions. fairly But, why weren't these questions asked during the year? Had we not scheduled an informal session on GMRS. would they be unanswered Honest, folks, I'm not now? unbearable! I've managed to answer every letter received over the years, and have used several questions as the basis for articles.

The second thing learned at convention is that members are crying for training. The GMRS Task Group will prepare a training manual for presentation at the next convention - along with - we hope - a training film that may be rented, copied and returned.

Until then let's answer a Whv of questions. couple use GMRS, any way? Very simply, range and clarity. GMRS radio Ultra High Frequency has the range on direct to compete with CB radio. If a repeater is available, ranges of 40 miles to the repeater are not uncommon. If the person on the receiving end is opposite the repeater, that adds another 40 miles. Now, suppose you see an fifty and you're accident, miles from home. By talking

to the repeater, you can reach someone to call the authorities easily and clearly. That's the other advantage: FM communications are clearer than AM ... no skip ... no hash and mash. Disadvantages? Probably cost. An average walkie talkie runs around \$500.00 and boy do they go up from there!

OK, you say, but what's a repeater? Basically, just another radio with an antenna that's mounted in a high spot. Your five watt walkie-talkie transmits to the 50 watt repeater on one frequency... say 467.675 Mhg, the repeater accepts your transmission and simultane-

rebroadcasts ously 462.675 Mhz. The person you are calling has a radio which receives on 462.675 Simple, No? The ad-Mha. vantage is the height of the repeater antenna, and the allowable power of the re-A good repeater peater. antenna can be rather expensive but will increase the effective range of the radio/ repeater: in other words, the five watt radio into the 50 watt repeater with a six db gain antenna will sound like more than 100 watts.

Remember, though that the antenna height is more important than the power of the radio. The rough rule of thumb is that one foot inantenna height crease in yields one more mile Of course, that's range. dependent on terrain, build ings, and weathers.




#### NOMINATION & ELECTION COMMITTEE REPORT

Five nominations were received and accepted for two Field Director positions to be filled on the Board of Directors, they were: James E. Bear, Jacki MacDonald, Ronald O. Mayes, Robert Riechel and Russell Willis.

Ballots were mailed to all REACT Teams with specific

instructions on filling out the ballot and mailing. The ballots were picked up at the Spokane Post Office by Mr. Marv Wyrick of the Spokane County Team and myself after the Post Office had placed all mail received on the deadline date, July 21, 1990.

# FEMA - WHO DECIDES WHETHER FEDERAL FUNDS WILL BE AVAILABLE FOR DISASTER AID?

During the hectic days after Hurricane Hugo and the earthquake in California. many accusations were hurled over the media, and grumbled about in private, because of the apparent delay in receiving federal aid. FEMA was criticized bv members of Congress and local officials at the disaster As a result of this. FEMA is resetting some of its priorities which may effect the way they do business, such as reducing barriers to assistance applicants, automating the applications, teleregistration, ect.

But even before these lataccusations. est concern had expressed that been possibly politics was entering decision into the making process causing delay and. at times, resulting in unfairness in administering the fund.

In a copyrighted story in the March 1990, Disaster News Report this issue was dis-Because of quescussed. tions raised regarding the maior disaster declaration process, the U.S. General Accounting Office had been directed as early as 1988 to undertake a study of the process and report to congress.

The three main areas examined were:

- 1. The time frames involved in reaching a major disaster declaration decision, including the amount of time the White House spent in making its decision.
- 2. The procedures for making the declaration deci-

sion and other information public.

**3.** Indications, if any, of political party affiliations influencing the decision.

The request for federal funds starts at the local levels. FEMA's regional office personnel and state and local government representatives tour the disaster area and make preliminary damage assessments. The governor of the state then determines whether the situation is beyond the capability of the state and local governments to manage.

The FEMA regional office prepares a regional summary which includes the governor's request and the information gathered during damage assessment tour and presents these to FEMA headquarters for re-The FEMA Director view. decides on the recommendation to be presented to the President of the U.S.

The White House notifies FEMA by phone of the President's decision. FEMA then relays this information to the regional director, who notifies the governor and the appropriate congressional delegation.

According to the Disaster News Report of the "33 major disaster declaration requests reviewed, 22 resulted in declarations and 11 were turned down." Only in one case did the White House FEMA's recommenreverse dation when it chose to declare a major disaster contrary to FEMA's recommendation. "The time between the FEMA recommendation and the White House average 3.5 days, two days for requests resulting in declarations and seven days when

requests were denied."

The system of processing the requests for federal funds involves enough individuals of varying rank and party affiliation that, after examining the declaration procedure and the party affiliation of key state officials in 22 major disasters, the commission found no indication that politics had a role in the decision.

The ability and willingness of the federal government to assist when severe disaster strikes an area continues to be one of the greatest encouragements to local volunteer agencies that are overwhelmed in these situations. FEMA is planning several conferences for information management people other "players" in the major disasters to try to improve both the perception if its role and the efficiency of its role in times of disaster.

## FEMA APPROVES FEDERAL AID TO HELP BATTLE ALASKA FIRE

The Federal Emergency Management Agency (FEMA) has authorized supplemental federal funds to help Alaska battle the Tok River fire which was determined to be a threat to populated areas near the city of Fairbanks.

FEMA approved the state's request for federal fire suppression aid late Thursday (July 5). The fire, located about 200 miles southeast of Fairbanks, started on July 1

and so far has burned more than 20,000 acres of forest and grasslands.

Under the authorization, the agency will pay 70 percent of the state's eligible firefighting costs that are above \$672,900. The figure, called a floor cost, is derived through a formula based on the state's five-year annual average cost for fighting fires.

Federal fire suppression aid, provided through the President's Disaster Relief Fund, is made available by FEMA to assist in fighting fires when they threaten to cause a major disaster. The agency said it could not presently estimate the amount of federal money that will be needed to control the Tok River fire.

#### AID **AUTHOR-**DISASTER FOR CALIFORNIA IZED FIRE **VICTIMS**

President Bush authorized federal disaster aid for California because of damages to homes and public property from wildland fires that broke out in the southern part of the state on June 26.

The Federal Emergency Management Agency said the President's major disaster declaration followed reports of fire damages to some 1,225 homes. including more than 560 dwellings which were either destroyed or heavily damaged.

Immediately after the President's action. FEMA Acting Director Jerry D. Jennings designated the countries of Los Angeles and Santa Barbara eligible for aid

to affected residents and local governments.

Jennings said that more designations may be made when damage assessments are completed in other areas threatened by the fires.

The agency, which will coordinate the federal relief effort, said the assistance can include temporary housing, grants, low-interest loans to uninsured property cover losses, and other programs to help residents and business owners recover from the effects of the disaster.

Federal funding also will be provided to affected local governments to pay 75 percent of the approved costs for debris removal, emergency protective measures and the repair or replacement of damaged public facilities.

Net working exercises strongly recommended.


