





#### Lake Royale REACT

On Saturday February 24,Lake Royale *REACT* team 6239 hosted a table at the annual Lake Royale Business Expo. This is an annual event where local businesses and service organizations can meet the residents of Lake Royale to promote their products or services.



Along with Lake Royale *REACT*, Franklin County Sheriff Kent Winsteadand his elite Community Action Team (CAT) <u>http://www.fcsonc.org/patrol</u>/were present as was Lake Royale CERT. This was a great event that not only raised the awareness of *REACT* in our community, but also helped the team connect with first responders and community leaders.

The team had a looping *REACT* recruiting video projected on the big screen as well as copies of the *REACT* and other materials from *REACT* 

international. The display of CB base stations and a classic Turner +2 microphone was a great way to draw in the hidden community of CB radio operators. Ham gear on display also surfaced amateur operators and those wanting to be hams.

Of course we heard a comment or two like, "Wow, I did not know *REACT* was still around," but then again that is exactly why we were there. We have some prospective new members, but more importantly the community knows that we are there to provide emergency communication when storms hit or the power goes out--- both of which are



common in our neck of the woods.

A key message to the community is that our team has three strong CB base stations with a fourth on the way that will monitor channel 9 when times get rough or the power is out (yes we all have backup power). We also will be hosting a weekly CB net to encourage those with CBs to test them out with us and get used to connecting with *REACT*.

Yes, Lake Royale REACT is all over VHF, UHF,

Ham and even Marine radio technology, but CB lives at Lake Royale and we aim to bring back the good old days of CB friendliness and availability in our isolated, but tight community.

The CAT is a four-person team, with the positions held by Cpl's Tharrington, Gunter (K-9 Officer), Strickland, and Corporal D. Barrett (K-9 Officer). They recently added two members to the team, K-9



Oli and K-9 Ace.

Their main responsibility is the safety and well-being of Franklin County citizens and visitors; therefore, the team assists the other units of the Sheriff's Office by taking enforcement action in an effort to make the county a safer place to live. The Community Action Team is community oriented, dedicated to enforcing traffic laws, conducting drug enforcement, answering calls for service, serving warrants, and hosting and attending special county events.

This is a charity race dubbed "Superhero 5K" as many participants cosplay as their favorite superheroes.


We have other events in our future including the largest event in the county, the Fabulous 4th of July in Flagler Beach. Even though it is only March we

**TRAINING COMPLETIONS:** Since August 2017 there have been 42 successful completions of *REACT* courses by 12 members from 6 Teams for 108 hours of training. Congratulations to:

**NEW** *REACT* **COURSE:** Two new *REACT* course are available on the website:

<u>Alerting</u> – covers how alerting works and the Activation Levels being used to help track Team readiness for major emergencies and disasters. You should be able to complete this course in 1 to 2 hours.

<u>Using the Zello Voice Traffic and Operations</u> <u>Nets</u> – covers the use of Zello to conduct the *REACT* Nets operated by the Training and Operations Committees. You should be able to complete this course in 1 to 2 hours.

**RESOURCE TYPING UPDATE:** The third Type IV resource is the Message Team (again a two person team). This team operates one of the three nets managed by the Training and Operations Committees – *REACT*/Traffic System, *REACT*/Command Net, and the Zello *REACT*/Standby Net. Our goal for 2018 is to have one qualified Type IV Message Team in each Region. Training for the Message Team includes:

FEMA Independent Study courses:

IS-100, 200, 700, and 800.

REACT Courses:

Disaster Basics

Using the Zello Voice Traffic and Operations Nets

Using the Traffic System Message Bulletin Board

Messages – Radiogram

Messages – ICS Form 213

Protecting Personal and Sensitive Information Introduction to Net Operations

Licensed as an Amateur Radio Technician OR one of the following *REACT* courses: GMRS, FRS, CB

Basics of Drills and Exercises

All courses should take 3 hours or less to complete. Members serving as Message Team Bosses have some additional training – contact training@*react*intl.org for a complete list.

By mid-April we expect to be ready to start credentialing Team members and Type IV Teams.

SUCCESSFUL MESSAGE RUNS: In a test of procedures for high speed voice transmission of messages two members successfully copied 100 words per minute:

**ALERTEX 2018-B:** Dates for ALERTEX 2018-B will be 23-25 May for the scenario buildup messages and 26 May for the impact

and response phase. Expect training packages the first week in April – if you have not received your package by 7 April, please contact training@reactintl.org immediately. The scenario will include East Coast, Gulf Coast, Caribbean, and West Coast hurricanes. We are planning for significant reporting play from Teams to Radio Relay International for simulated forwarding to federal authorities.

AND ALERTEX 2018-A WINTER STORMS RILEY, QUINN, SKYLAR: The end of February and the first of March very busy for *REACT* were message operations, with one exercise and three actual system activations for Winter storms. We generated warning messages, received reports from Teams, and provided the *REACT* Regional Directors daily situation reports summarizing *REACT* response efforts. Some lessons learned:

Kudos to Northern Rhode Island *REACT* for reporting in all three Winter Storms, and to Prince George's County *REACT* for their reporting in Winter Storm Riley. These two Teams pushed information to the Traffic System before we asked for it.

Kudos to Regional Director Thomas Currie for inputs to the design of the daily *REACT* Situation Report to improve the value of the information for Regional Director decision making.

The number of Teams that do not open e-mail during a disaster, whether simulated or actual, is troubling. We hit almost 50% with the Winter Storm Riley alerting message, but our normal percentage is in the low 30% range. We are developing a capability to provide early warning information to Teams, a capability will continue to grow as the Operations Committee becomes operational. Teams that do not open their e-mail, or that do not have e-mail at all, risk missing information directly affecting the safety of their members and equipment.

In ALERTEX 2018-A 12 Teams opened at least 5 of the 6 scenario messages, but did not

do either of the two exercise tasks.

The second part of this is that in Riley we were on the edge of having an event where not reporting means that we will have to start calling Teams to make sure they have not suffered catastrophic loss. This is a basic safety and accountability issue.

The quality of reports we received from Teams was quite good. This is important because *REACT* may have an opportunity to become part of a network of ground truth reporting stations in the future.

The work load is significant. For Skylar, the least involved response, the Traffic System transmitted 84 messages. The challenge is now to train an incident management team that can help manage the information flow. If you are interested, contact:

#### QUALIFICATIONS TO RUN FOR BOARD of DIRECTORS

Nine (9) Directors shall be persons from within the *REACT* membership who have demonstrated leadership experience at *REACT* Team and/or Council level, other nonprofit corporations or public agencies; are at least 21 years of age; and are members in good standing of any *REACT* Team for more than three (3) years.

Directors shall be members of Teams in the regions they represent. (1) Eight (8) Directors shall be elected from regions of the United States, as defined by the Board of Directors. (2) One (1) Director shall be elected from a region composed of Teams in countries outside the United States. (3) Directors shall be elected on a rotating basis (three regions each year).


Each Director shall hold office for three (3) years subsequent to election or until his/her successor shall have been elected and qualified or until his/her death, resignation, or removal or until he or she ceases to be a member of a *REACT* Team within the region (provided, he/she represents however, that if a Director's Team is moved to another region by the Board of Directors, the Director will remain qualified until the end of his/her elected term).

Member Chairman because we need to get our Life Members together more. I want to see us become a voice within *REACT* that we haven't seen.


The Life Members have been here forever, and it's about time that we are a part of things.

It has been some time since there has been an actual voted in Chairman of this committee and while I am not sure who nominated me, I thank them for their confidence in me.


While I do not necessarily seek the position, if elected, I will serve to the best of my ability and will attempt to bring cohesion to the Life Member ranks and purposes.

# From The Corner of the Room

Well, it is almost April and summer will be knocking on the door! It's time now to get outside and get that antenna checked out. Speaking of antennas please go to this website, do not miss this website www.hamuniverse.com/jpole.html


You can go to Lowe's or Home Depot and buy 10 feet of  $\frac{1}{2}$ " copper pipe the long straight piece for about \$10.00, with a  $\frac{1}{2}$ " copper "T" and one  $\frac{1}{2}$ " copper 90° elbow. All these cut to length you have an awesome antenna that will work as good or better than one you pay big money for.

The web site will show what length to cut the pipe for your desired frequency. I suggest mid band of your frequency range. This antenna is simple to make and will do a super job. I have made 40 to 60 mile simplex contacts on this \$14.00 antenna. We are talking about the "Copper J- Pole Antenna". Way back in the day these antennas were called 'zeppelin antennas' because, you guessed it, they were used on the big zeppelin air ships. Easy to build for 400 Mhz or the 140 Mhz frequencies. All the members in our radio club have a Copper J-Pole which, easily hooked to your Baofeng® radio with a 25 or 50 foot coax cable with the proper adapter, works great.

We have tested the Baofeng® and got 40 plus miles out of just 5 watts. There is easy simple soldering skills needed but this antenna will last you forever, and as always the higher you get the antenna in the air, the better performance you get.

Build one and send a letter to Letters to the Editor of The *REACT*er (<u>editor@thereacter.com</u>) and let us know how you did. Send some pics!





ALERTEX 2017 was successfully conducted on 17-18 November, with 10 Teams completing the availability report listing 109 members ready for duty, with 44 Type IV Communications Teams available for assignment within a 25 mile radius local area for 12 hours, including 34 Type IV teams available for assignment for 72 hours outside their local areas. An additional 7 Teams acknowledged receipt of one of the two messages, but did not report availability. Our exercise schedule for 2018 includes Internet based exercises in February, May, August, and November. We have developed a strategy for resource typing for 2018. This includes Type IV resources in 2018: Communications Teams, Fixed Base Communications Teams, and Message Handling Teams. The Fixed Base resource will allow virtually all active Teams to have at least a Type IV resource. The Committee is starting work on a dedicated Zello voice traffic net to complete the *REACT* Traffic System.


